



FUNDING FOR GOVERNMENT PROJECTS

PROYTEC PANAMA CORP.



The process for applying for financial assistance from the **UNITED STATES FOREIGN TRADE INSTITUTE** for any Government project is as follows:

- Governments and Organizations requesting assistance must send a formal letter on headed paper to PROYTEC PANAMA CORP., signed in the original in light blue ink and stamped, officially requesting assistance, and indicating the reason.
 - This letter should explain in as much detail as possible the type of assistance needed such as a request for funds for a project, a request for new technology, assistance in selling securities, high value assets or property in the international market.
- 2) All submitted projects will be analyzed by PROYTEC PANAMA CORP., accompanied by a report from the Company and presented to the INSTITUTE for certification.
- 3) The INSTITUTE certification process requires the following:
 - a) Once the project accompanied by the report of PROYTEC PANAMA CORP. has been presented, the logistics department in Washington DC. analyzes it and if the project is approved in the first instance, the INSTITUTE's Dean's Office sends an official communication to the applicant informing that the project has been approved in the first instance and that the second step is to certify the project.
 - b) For the certification of the project it is necessary that two Officials, with international consultancy of category III, go to the Country or Region in which the project will be carried out to personally verify that what is stated on paper is real and that there are no problems economic, technical, or legal for the project to be carried out.
 - c) The COST OF PROJECT EVALUATION by the Logistics Department is COVERED BY THE INSTITUTE.
 - d) The COST OF THE DAILY ALLOWANCE FOR THE OFFICIALS who will travel to the country or region where the project will be implemented is COVERED BY THE INSTITUTE.
 - e) The COST OF TRAVEL EXPENSES which includes business class air tickets, if the journey is more than 2 hours, plus accommodation in a first-class hotel in the city center, meals, internal transportation, and communication plus \$200 for expenses ancillary, per day per Officer SHOULD BE COVERED BY THE APPLICANT. For security and logistics reasons, all airline tickets, hotels, and more must be purchased and coordinated by the INSTITUTE.
 - f) Any other unforeseen unplanned expenses which may be necessary for certain projects, such as special studies or the need for the assistance of an expert in a certain field for a professional opinion, will be borne by the applicant.
- 4) Once the certification is completed, the INSTITUTE will proceed with the financial assistance as follows:
 - a) Typically, the complete process for any project takes a minimum of 6 months.
 - b) Loans can be granted to national governments, regional governments or directly with local government bodies or municipalities.
 - c) These projects must be guaranteed by sovereign wealth funds and other institutional guarantees, they are carried out directly with the competent Authorities and if everything is in order, the INSTITUTE will provide a complete package that includes financing at very low rates and world-class companies that will carry out the project.
